



AGREEMENT FOR HANDING OVER THE MANAGEMENT AND MAINTENANCE OF THE ASSETS CREATED

Community Centre Kumpurupitty North

This Agreement entered into on the October 2003 between the Integrated Food Security Programme Trincomalee, hereinafter referred to as the **IFSP**

and

The President and Secretary of the **PRADESHA SABA KUCHCHAVELI**, situated in the DS Division Kuchchaveli, Trincomalee District, for the handing over and taking over of the management and maintenance of the Community Centre Kumpurupitty North which was constructed by the **RURAL DEVELOPMENT SOCIETY KUMPURUPITTY NORTH** under the **IFSP** agreement no. 06/2000.

- 1) The President and Secretary of the **PRADESHA SABA KUCHCHAVELI** on behalf of the Government agrees to take over the said project and agree to undertake the full responsibility of maintenance and operation activities with effect from the date of signing this agreement.
- 2) The President and Secretary of the **PRADESHA SABA KUCHCHAVELI**, on behalf of the Government and the **RURAL DEVELOPMENT SOCIETY KUMPURUPITTY NORTH**, on behalf of all members, agree to fulfil all responsibilities described in the maintenance plan. This includes:
 - Operating the Community Centre for the benefit of the village communities.
 - Taking care of the community centre and keeping it in a good condition.
 - Ensuring periodic maintenance and repair of minor damages.
 - Engage the members of the community in maintenance and protection.
 - Reporting any events to the **PRADESHA SABA** for timely assistance.
- 3) Any conflict regarding the implementation of this agreement will be resolved mutually by consultation, consensus and compromise amongst the members of the community, represented by **RURAL DEVELOPMENT SOCIETY KUMPURUPITTY NORTH** and the **PRADESHA SABA KUCHCHAVELI**. Failing such mutual resolution it is agreed upon that the matter will be brought before the Divisional Secretary's Divisional Coordinating Committee and its decision shall be final.
- 4) The President and Secretary of the **PRADESHA SABA KUCHCHAVELI** and the **RURAL DEVELOPMENT SOCIETY KUMPURUPITTY NORTH** agree to include the Community Centre, which was constructed by the **RURAL DEVELOPMENT SOCIETY KUMPURUPITTY NORTH** under the **IFSP** agreement no. 06/2000 in the village development plan.

- 5) The **PRADESHA SABA KUCHCHAVELI** will in future support the community and facilitate cooperation and coordination with the **RURAL DEVELOPMENT SOCIETY KUMPURUPITTY NORTH** and the **Divisional Secretary KUCHCHAVELI**.

We are happy to hand over the above mentioned successfully completed project. We are expecting a proper maintenance of the project in future by the **PRADESHA SABA KUCHCHAVELI** and the **RURAL DEVELOPMENT SOCIETY KUMPURUPITTY NORTH** in cooperation with the **Divisional Secretary Kuchchaveli**.
